ARTWORK GUIDELINES AND SUBMISSION

Guidelines for Artwork

1. File type: Vector EPS (encapsulated Postscript) format created in a vector drawing program (Adobe Illustrator CS5 or lower).
2. Three versions of the company logo (six if both horizontal and vertical aspect versions are available):
 - a. A version in color suitable for a white/light background
 - b. A version in color/reversed suitable for black/dark background
 - c. A version in grayscale

3. All type must be converted to outlines.
4. All required registered marks, trademarks and service marks should be part of the logo artwork.
5. Corporate tag lines cannot be part of the logo artwork.
6. Nasdaq cannot accept logos in the following applications and file formats: Adobe Photoshop or InDesign, Microsoft PowerPoint, Word or Excel, Corel Draw, or QuarkXpress.
7. Nasdaq cannot accept flattened artwork (JPEG, GIF, PNG, BMP or TIFF).
