# 3. <u>Self-Regulatory Organization's Statement of the Purpose of, and Statutory Basis</u> for, the Proposed Rule Change

With this delay, the Exchange would continue to assess the ORF that was in effect in December 2024 of \$0.0013 per contract side for January 2025 transactions and thereafter until June 1, 2025. In light of a comment letter from SIFMA dated December 20, 2024, 6 the Exchange proposes this delay to provide market participants additional time to track the new ORF charges on both Local and Away executions in the "Firm" range. This delay would allow market participants the additional time needed to design, test and implement changes to the ORF.
