**Partial Amendment No. 1 to SR-NASDAQ-2013-079**

The NASDAQ Stock Market LLC (“NASDAQ” or the “Exchange”) is filing this Partial Amendment No. 1 to SR-NASDAQ-2013-079 to make the following change to the pending 19b-4 and Exhibit 1.

(1) Substitute, in its entirety, the first sentence of the second full paragraph on page 12 of 35 and the first sentence of the third paragraph on page 28 of 35 with the following sentence:

“ The Adviser represents that it does not believe that the ability of the Funds’ agent to calculate NAV and an indicative intra-day value (“IIV”) for each Fund, and disseminate such IIV every 15 seconds throughout the trading day, has been impeded by the Funds’ current Rule 144A holdings limited to 15% of net assets. ”

This Partial Amendment No. 1 is done to reflect a change clarifying the location of the term “NAV” in the noted sentence, and to conform the 19b-4 and Exhibit 1.

The Exchange believes that SR-NASDAQ-2013-079, as amended, remains consistent with the Securities Exchange Act of 1934 (“Act”), and specifically with Section 6(b)(5).
