Partial Amendment No.1 to SR-NASDAQ-2014-059

The NASDAQ Stock Market LLC (“NASDAQ”) is filing this Partial Amendment No. 1 to SR-NASDAQ-2014-059 to make the following change to the pending 19b-4 and Exhibit 1:

1. In footnote 11 at the bottom of page 8 of 64 of the 19b-4, as well as in footnote 11 at the bottom of page 38 of 64 of the Exhibit 1, replace “(a)-(k)” with “(b), (d), (f), (g), (h), (i) and (j)”.

The proposal SR-NASDAQ-2014-059, as amended, remains consistent with the Securities Exchange Act of 1934, and specifically with Section 6(b)(5) because it makes technical and clarifying changes to the filing and does not make any changes that are unique or novel. Partial Amendment 1 specifically clarifies which subsections of Nasdaq Rule 5711 are applicable to pooled investment vehicles that invest primarily in commodities and commodity-linked instruments.
