## Partial Amendment No. 1 to SR-NASDAQ-2014-073

The NASDAQ Stock Market LLC ("NASDAQ") is filing this Partial Amendment No. 1 to SR-NASDAQ-2014-073 to make the following change to the pending 19b-4 and Exhibit 1:

1. At the end of the first line on top of page 16 of 68 of the 19b-4, as well as at the end of the second full paragraph on page 48 of 68 of the Exhibit 1, insert as a new sentence "Reverse repurchase agreements will not be used by the Fund to enhance leverage."

The proposal SR-NASDAQ-2014-073, as amended, remains consistent with the Securities Exchange Act of 1934, and specifically with Section 6(b)(5) because it makes technical and clarifying changes to the filing and does not make any changes that are unique or novel. Partial Amendment 1 specifically clarifies that the Fund will not use reverse repurchase agreements to enhance leverage.
