SR-NASDAQ-2015-049 Amendment No. 2

The NASDAQ Stock Market LLC (“NASDAQ”) is filing this Amendment No. 2 to SR-NASDAQ-2015-049 to make the following changes to the pending 19b-4 and Exhibit 1:

1. In the second sentence in the first full paragraph on page 9 of 40 of the 19b-4, and in the last line of page 27 of 40 of the Exhibit 1, the phrase “Each Fund, either directly or through its respective Subsidiary” is changed to “Each Fund, through its Subsidiary”.
2. In footnote 18 on page 9 of 40 of the 19b-4, and in footnote 17 on page 28 of 40 of the Exhibit 1, the term “Each Fund” is replaced with “Each Subsidiary” in both the first and second sentence of the respective footnote.

The proposal SR-NASDAQ-2015-049, as further amended, remains consistent with the Securities Exchange Act of 1934, and specifically with Section 6(b)(5) because it makes clarifying changes to the filing and does not make any changes that are unique or novel. Amendment No. 2 specifically further clarifies that Commodity Linked Instruments will only be held at the Funds’ Subsidiary level.
