**Partial Amendment No. 2 to SR-NASDAQ-2015-059**

The NASDAQ Stock Market LLC (“NASDAQ”) is filing this Partial Amendment No. 2 to SR-NASDAQ-2015-059 to make the following changes to the 19b-4 and Exhibit 1:

1. Replace the first sentence following the section “Other Investments” on page 7 of 50 of the 19b-4 and on page 31 of page 50 of the Exhibit 1, with “In order to seek its investment objective, the Fund may also invest in cash and cash equivalents, which may include only money market instruments, short duration repurchase agreements, and short duration commercial paper, and may also invest in U.S. exchange-traded options on securities and securities indexes.”

The proposal SR-NASDAQ-2015-059, as amended, remains consistent with the Securities Exchange Act of 1934, and specifically with Section 6(b)(5) because it makes clarifying change to the filing and does not make any changes that are unique or novel. Partial Amendment No. 2 specifically clarifies the term “cash equivalents” in the “Other Investments” section.
