# 3. <u>Self-Regulatory Organization's Statement of the Purpose of, and Statutory Basis</u> for, the Proposed Rule Change

a. <u>Purpose</u>

Nasdaq filed a rule change<sup>3</sup> which adopted a new protocol "Ouch to Trade

Options" or "OTTO"<sup>4</sup> and proposed to rename and modify the current OTTO protocol as

"Quote Using Orders" or "QUO."<sup>5</sup> The Exchange subsequently filed a rule change to

amend Chapter VI, Section 6(e), titled "Detection of Loss of Communication" which

describes the impact to NOM protocols in the event of a loss of a communication. The

Exchange accounted for both the new OTTO and renamed and modified QUO within this

rule. Similarly, the Exchange amended Chapter VI, Section 8, "Nasdaq Opening and

Halt Cross" to account for the new OTTO and renamed and modified QUO within this

rule. Finally, the Exchange amended Chapter VI, Section 19, "Data Feeds and Trade

Information" to amend "OTTO DROP" to "QUO DROP" and noted within Chapter VI, Section 18(a)(1) related to Order Price Protection rule or "OPP" that OPP shall not apply to orders entered through QUO.<sup>6</sup>

Both the Prior Rule Change and the Subsequent Rule Change indicated the aforementioned rule changes would be implemented for QUO and OTTO in Q4 of 2018 with the date announced via an Options Traders Alert. The Exchange filed a rule change implementing QUO and delaying the introduction of the OTTO functionality until Q3 2019 by announcing the date of implementation via an Options Traders Alert.<sup>7</sup> The Exchange further delayed the implementation of OTTO functionality until Q3 2019.<sup>8</sup> At this time, the Exchange proposes to further delay the implementation of OTTO functionality until Q2 2020. The Exchange will issue an Options Trader Alert notifying Participants when this functionality will be available.

The Exchange proposes this delay to allow the Exchange additional time to implement this functionality and for Participants to sign-up for this new port and test with the Exchange.

#### b. <u>Statutory Basis</u>

The Exchange believes that its proposal is consistent with Section 6(b) of the Act,<sup>9</sup> in general, and furthers the objectives of Section 6(b)(5) of the Act,<sup>10</sup> in particular, in that it is designed to promote just and equitable principles of trade, to remove impediments to and perfect the mechanism of a free and open market and a national market system, and, in general to protect investors and the public interest by delaying the OTTO functionality to allow the Exchange additional time to implement this functionality and for Participants to sign-up for this new port and test with the Exchange.

### 4. <u>Self-Regulatory Organization's Statement on Burden on Competition</u>

The Exchange does not believe that the proposed rule change will impose any burden on competition not necessary or appropriate in furtherance of the purposes of the Act. The Exchange's proposal to delay the adoption of the OTTO functionality does not impose an undue burden on competition. Delaying the OTTO functionality will allow the Exchange additional time to implement this functionality and for Participants to sign-up for this new port and test with the Exchange.

# 7. <u>Basis for Summary Effectiveness Pursuant to Section 19(b)(3) or for Accelerated</u> <u>Effectiveness Pursuant to Section 19(b)(2)</u>

The foregoing rule change has become effective pursuant to Section  $19(b)(3)(A)(iii)^{11}$  of the Act and Rule 19b-4(f)(6) thereunder<sup>12</sup> in that it effects a change that: (i) does not significantly affect the protection of investors or the public interest; (ii) does not impose any significant burden on competition; and (iii) by its terms, does not become operative for 30 days after the date of the filing, or such shorter time as the Commission may designate if consistent with the protection of investors and the public interest.

The Exchange believes that the proposal does not significantly affect the protection of investors or the public interest because delaying the OTTO functionality will allow the Exchange additional time to implement this functionality and for Participants to sign-up for this new port and test with the Exchange. The Exchange believes that the proposal does not significantly affect the protection of investors or the public interest because delaying the implementation of OTTO benefits the Exchange and Participants by allowing additional time to ensure a successful implementation.

Furthermore, Rule 19b-4(f)(6)(iii) requires a self-regulatory organization to give the Commission written notice of its intent to file a proposed rule change under that subsection at least five business days prior to the date of filing, or such shorter time as designated by the Commission. The Exchange has provided such notice.

At any time within 60 days of the filing of the proposed rule change, the Commission summarily may temporarily suspend such rule change if it appears to the

Commission that such action is: (i) necessary or appropriate in the public interest; (ii) for the protection of investors; or (iii) otherwise in furtherance of the purposes of the Act. If the Commission takes such action, the Commission shall institute proceedings to determine whether the proposed rule should be approved or disapproved.

A proposed rule change filed under Rule 19b-4(f)(6) normally does not become operative prior to 30 days after the date of filing. Rule 19b-4(f)(6)(iii), however, permits the Commission to designate a shorter time if such action is consistent with the protection of investors and the public interest. The Exchange requests that the Commission waive the operative delay to allow the Exchange to immediately delay the implementation of the OTTO functionality. This delay will provide additional time to implement this functionality and for Participants to sign-up for this new port and test with the Exchange. Delaying the implementation of OTTO is consistent with the protection of investors and the public interest because it permits additional time to ensure a successful implementation of the OTTO.
