Partial Amendment No. 1 to SR-Phlx-2012-40

NASDAQ OMX PHLX LLC (“PHLX” or “Exchange”) respectfully submits the following Partial Amendment No. 1 to proposed rule change SR-Phlx-2012-40.

Specifically, PHLX proposes to add on page 8 of the Form 19b-4 under Item 3.a, and page 18 of the Exhibit 1 under Section II.A.1, please add the following language to the end of the paragraph that currently ends with the words “in accordance with Rule 1014(b)(ii)(E)(2)”:

The Exchange believes that elimination of the 20% test would not detract from the Exchange’s current electronic trading environment. Additionally, the Exchange notes that the elimination of the 20% test would affect a relatively small number of non SQT ROTs.
