3. Self-Regulatory Organization's Statement of the Purpose of, and Statutory Basis for, the Proposed Rule Change

a. Purpose

The purpose of the proposed rule change is to amend the Table of Contents to include a reference to FLEX fees within the Pricing Schedule. The Exchange adopted new FLEX Option pricing in Section IV, entitled “Other Transaction Fees,” Part B of the Pricing Schedule in a previous rule change and inadvertently did not amend the Table of Contents to reflect the addition of that pricing to Section IV.⁴ The Exchange proposes to amend the Table of Contents to add FLEX Pricing and also reletter Section IV, Part B, entitled “Cancellation Fees,” and Part C, entitled “Options Regulatory Fee,,” as Parts C and D, respectively.

The Table of Contents allows members to readily locate pricing within the Pricing Schedule. The Exchange is not proposing any substantive amendments, but rather proposes to merely amend the contents of the Table of Contents.

b. Statutory Basis

The Exchange believes that its proposal is consistent with Section 6(b) of the Act⁵ in general, and furthers the objectives of Section 6(b)(5) of the Act⁶ in particular, in that it is designed to promote just and equitable principles of trade, to remove impediments to and perfect the mechanism of a free and open market and a national market system, and, in general to protect investors and the public interest, by providing

market participants an easy format to readily locate pricing with other transaction fees which may be applicable to them. The Exchange believes that also correcting the Table of Contents provides greater clarity to the Pricing Schedule.

Pursuant to Section 19(b)(1) of the Securities Exchange Act of 1934 (“Act”),¹ and Rule 19b-4 thereunder,² notice is hereby given that on September 19, 2013, NASDAQ OMX PHLX LLC (“Phlx” or “Exchange”) filed with the Securities and Exchange Commission (“SEC” or “Commission”) the proposed rule change as described in Items I, II, and III, below, which Items have been prepared by the Exchange. The Commission is publishing this notice to solicit comments on the proposed rule change from interested persons.

I. Self-Regulatory Organization's Statement of the Terms of Substance of the Proposed Rule Change

The Exchange proposes to amend the Table of Contents to its Pricing Schedule to refer to FLEX³ fees which were inadvertently not added to the Table of Contents at the time the fees were adopted.
